About this Conference

Justice Andre Maniam was appointed Judicial Commissioner of the Supreme Court on 4 May 2020 and High Court Judge on 1 November 2021.

He graduated from the National University of Singapore as the top law student in his year.

Before joining the bench, Justice Maniam had almost 30 years of experience as a lawyer, with the last 10 years as a Senior Counsel involved in dispute resolution across a wide range of subject areas.

11.10	AI in Delay Analysis: Promise, Peril, and Who's Responsible When It Goes Wrong AI tools are now used across the claims lifecycle – document review, critical path analysis, quantum, even the narrative. At their best, they are genuinely transformative: interrogating thousands of documents in hours, running multiple delay methodologies on the same facts, and bringing a consistency that reduces the risk of analysis being shaped by who is paying for it. That is the promise. The peril is that AI is also wrong in ways that are genuinely hard to detect. In disputes already running – where one expert has used AI and the other hasn't, where the critical path was identified by an algorithm nobody can fully interrogate – the SCL Protocol's demand for transparent methodology meets its sharpest test. If AI misidentifies the critical path, who bears responsibility – the expert, the software provider, or the instructing party? Professional indemnity policies and the rules of evidence were not written with this in mind. In this session, our panellists will share their insights and experience on the use of AI on the delay analysis process.

SESSION 3

Digital Evidence and the Future of Construction Disputes

The digitalisation of the construction industry is transforming how disputes are evidenced, analysed and resolved, elevating digital project records – such as Building Information Modelling (BIM) models, drone surveys, sensor data and digital forensics – into primary sources of expert evidence. In modern disputes, BIM and digital twin data can chronicle design intent, construction sequencing and as-built conditions with precision that traditional paper-based records cannot match, and arbitrators increasingly rely on digital forensics to establish causation and quantify impacts of delays or defects. At the same time, this proliferation of data shifts the role of expert witnesses – who must now interpret complex datasets, validate technical outputs, and present digital evidence that meets legal standards of authenticity, integrity and relevance – raising new legal and procedural issues in disclosure, admissibility and expert reporting. As such, this session will explore how digital evidence is reshaping expert testimony, dispute strategy, and evidentiary protocols in contemporary construction law.

Debate: In AI We Trust? The Evidential Risks of Automating Project Records

Meet our newest contract managers: Claude, Jarvis, and Vincent. They don't walk site, don't argue in meetings, and don't exercise judgment—yet they never miss an email, never forget to minute a discussion, and can generate a perfectly timestamped project record in seconds.

They aren't human. But in an industry where disputes live or die by contemporaneous records, they may soon be the most powerful voices in the room.

The real question is not whether AI can automate project record-keeping; it already can. The question is whether we should trust it to do so, and how far we dare to delegate functions that have traditionally sat at the heart of professional judgment. Who decides what becomes the "official" project narrative when an algorithm curates the record? What happens to context, nuance, and silence—the things seasoned practitioners instinctively weigh—when machines document everything? And when a dispute lands before a tribunal or the Singapore courts, will AI-generated records be treated as objective truth, convenient fiction, or something more dangerous?

Join our panel of debaters as they grapple with an uncomfortable question for lawyers, contract administrators, and claims professionals alike: are we using AI as a tool—or are we training our own replacement witnesses?
